Gate Widths: Average width 71.5", narrowest is 69.5". Gate sizes will not be changing anytime soon.

Dust control: A chemical can be used, however creates rust on machines, we use reclaimed blacktop.

Correction from August newsletter: Forest Land Group were the previous owners of the property. The Conservation Fund (new property owners) bought approximately 80,000 acres of Forest Land Group property. The DNR is purchasing a conservation easement (from The Conservation Fund) on 12,500 acres of this property in the Pelican lake area. The plan is to open the roads to licensed vehicles. ATV/UTV use were/are still being discussed, but that is not a guarantee at this point.

6th ANNUAL WOODPECKER RIDE

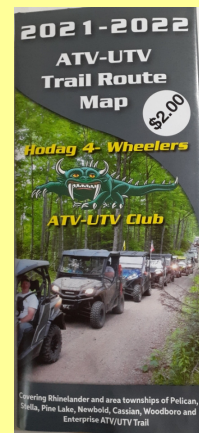

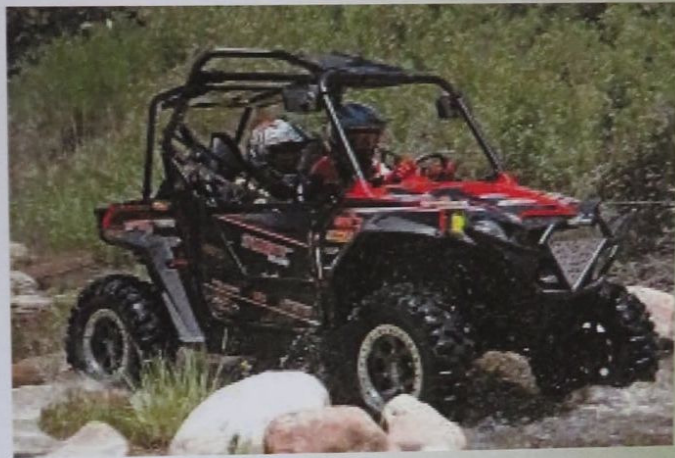
6th Annual ATV-UTV RIDE
