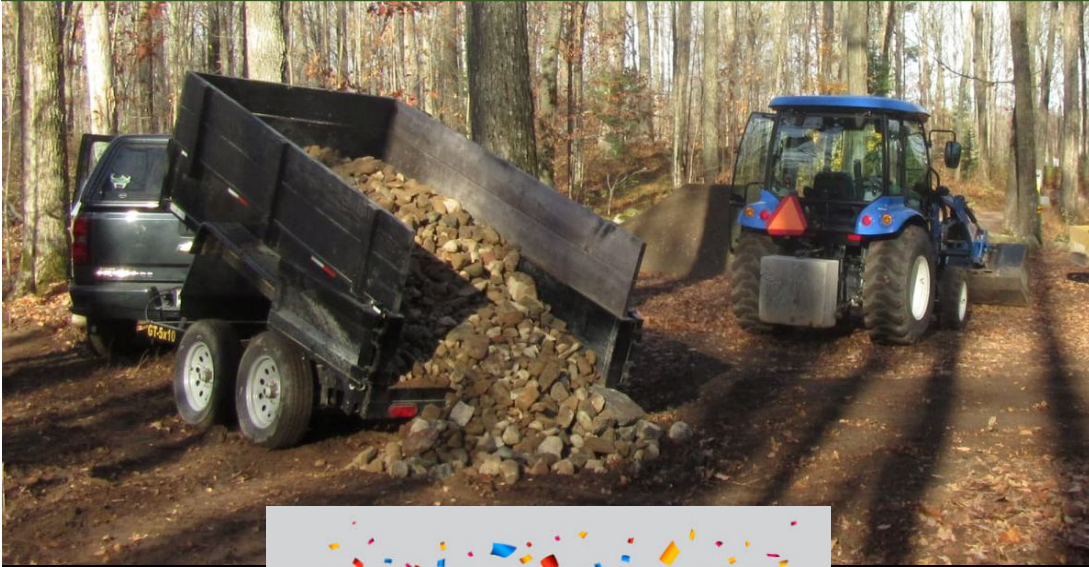


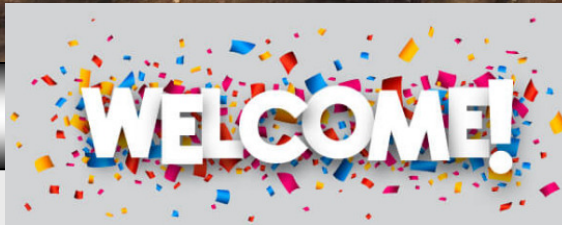

Taking nominations up to December 15th meeting. Current officers will remain if no other nominations come forward.

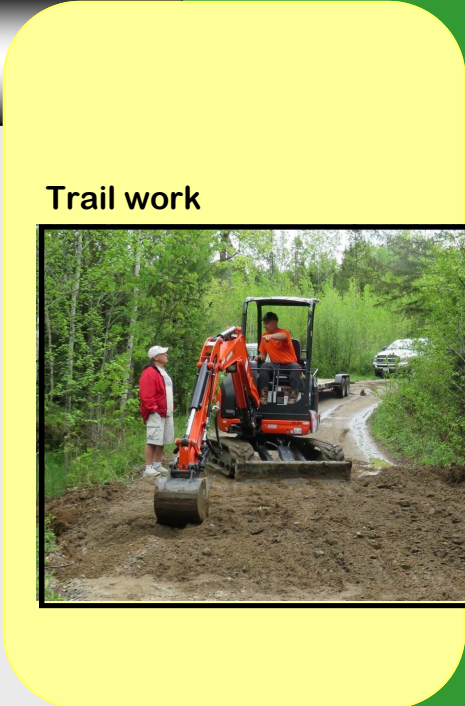
President / Treasurer / Trail Coordinator

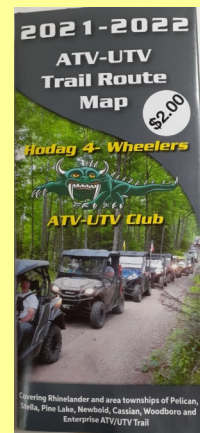
